The objectives of these activities being;


- Reducing the quantity of water, energy and consumables used in process;

Our Management System

This document forms a small part of our overall management system which has been developed to comply with the requirements of ISO 14001 environmental management system.

The principles of our management system are built upon the 'Plan–Do–Check–Act' model, whilst considering further strategic risks such as stakeholders, internal and external influencing factors. The scope of our environmental management system is;

The management of Post consumer plastic packaging waste for segregating and recycling to produce a feedstock material separated by polymer type and colour for supply to internal and external customers in the following formats: -

- Various polymer Baled products,
- Various polymer Recycled plastic Resin/Pellet product.
- The production of extruded, blown flexible/rigid plastic products, as example LDPE (polythene) bags, bags for life. Shrouds for PP big bags and PET Food contact sheet.
